Your rights

You have the right to obtain from us without undue delay **rectification** of any inaccurate personal data concerning you and, if applicable, the completion of any incomplete personal data.

You have the right to obtain from us the erasure of your personal data without undue delay if one of the reasons listed in Art. 17 GDPR applies, e.g. if the data is no longer required for the purposes for which it was collected (**right to erasure**).

You have the right to obtain from us the **restriction of processing** if one of the conditions listed in Art. 18 GDPR is met, e.g. for the duration of the verification by us if you objected to the processing. You have the **right to object** to the processing of your personal data at any time on grounds arising from your particular situation. We will then no longer process the personal data unless we can demonstrate compelling legitimate interests, which override your interests, rights and freedoms or the processing is necessary for the establishment, exercise or defence of legal claims.
